

### NOTICE OF SELECTION FOR THE ASSIGNMENT OF 2 RESEARCH SCHOLARSHIPS AT THE UNIVERSITY OF BASILICATA WITHIN THE FRAMEWORK OF THE TRANSNATIONAL PROJECT TNE 23-00011

(PUBLIC NOTICE – SELECTION FOR THE ASSIGNMENT OF 2 SCHOLARSHIPS,

Ref. Directoral decree n. 90/2025)

### Article 1 - Selection process

A selection process is hereby announced for the assignment of **2 scholarships** for advanced training activities for international students within the framework of the project "Supporting Universities in Digital Transition, Educational Innovation, & Environment Protection Fostering the Launch of Italian Educational Institutions Abroad (SULIEIA)." This initiative aligns with the provisions of the National Recovery and Resilience Plan (PNRR) – Mission 4 – Component 1, "Enhancing Education Services from Early Childhood to University," Investment 3.4, "Advanced Teaching and University Skills," Sub-investment T4, "Transnational Initiatives in Education", codice TNE23-00011 - CUP E41I24000240006, funded by the European Union – NextGenerationEU.

For the purposes of this notice, international students are defined as individuals who, regardless of citizenship, have obtained the qualifications required for admission to the selected Bachelor's or Master's degree programs from an institution outside the Italian education system.

#### Article 2 - Eligibility Requirements

Applications for the scholarship are open to all international students (European and non-European) from the partner and affiliated universities of the SULIEIA project.

#### Article 3 - Admission Requirements

- A Master's degree in scientific disciplines.
- Proficiency in the English language.

## Article 4 - Selection Criteria

The selection process will be based on qualifications. The evaluation by the selection committee will consider the following criteria, with a maximum score of 15 points:

- Academic and professional achievements (Curriculum Vitae, certificates, recommendation letters, portfolio, etc.): up to 10 points.
- o English language certification: up to 5 points

In case of a tie score, an online interview will be held via a platform to be agreed upon.

## Article 5 - Scholarship Details

Each scholarship will have a duration of 7 days, from 29 June 2025 to 04 July 2025, and including meals, accommodation and local transportation for a total of € 850,00.

The travel costs will be covered separately on the basis of the real costs with a maximum reimbursement of € 250.00.









## Article 6 - Submission of Applications

Applications, duly signed by the applicants, must be submitted no later than **12:00 PM on 16 June 2025** via e-mail in PDF format to the following e-mail address: **sulieia@unibas.it** 

The application must include the following information:

- o Full name;
- Date and place of birth;
- Residence;
- o Citizenship;
- Email address for correspondence;
- Name and surname of the affiliated reference person at the Università degli Studi della Basilicata Basilicata (Professor Luigi Milella).

## **Required Documents:**

- o Curriculum Vitae;
- o List of qualifications and/or publications;
- Certificates (seminars, master's degrees, doctoral research, professional development courses, training programs, activities at research institutions, etc.);
- o A valid identification document;
- Recommendation letter from the affiliated sending department reference person for the project.

### Article 7- Evaluation Committee

The evaluation committee will consist of two professors and one administrative staff member, designated by the Director of the Dipartimento di Scienze della Salute (DiSS) of the Università degli Studi della Basilicata.

#### Article 8 - Ranking and Tie-Breaking Criteria

The committee will compile a ranking list, indicating eligible candidates in order of merit. In the event of a tie, the scholarship will be awarded to the younger candidate. Female candidates, or those identifying as such, will receive an additional bonus of 2 points in accordance with the project guidelines. The committee's decisions are final and binding.

#### Article 9 - Scholarship Assignment

The scholarship will be awarded to the candidate with the highest score. Should the winner decline the scholarship, it will be assigned to the next eligible candidate based on the merit ranking.

## Article 10 - Obligations of the Scholarship Recipient

The recipient must:

- a) Commence activities on the agreed date as determined by the institutional referee.
- b) Perform the activities regularly and continuously for the full duration of the scholarship.
- c) Submit a comprehensive and documented report on the activities performed at the end of the course
- d) Attend the ISSNP school more information at https://www.issnpschool.org/

The recipient is subject to the attendance requirements of the enrolled course.







## Article 11 - Forfeiture of Scholarship

The recipient will forfeit the scholarship if they fail to fulfill any of the above obligations or are found guilty of any serious misconduct.
