NOTICE OF REOPENING

STAFF MOBILITY FOR RESEARCH, TEACHING AND TRAINING

Application window: from the date of publication until 24:00 on **15th January 2025**

Referring to the “Call for Staff Mobility for research, teaching and training”, issued by Director’s Decree n. 2055 Rep. n. 235/2025 on 24/07/2025, the deadlines are reopened for submitting applications for **staff mobility for research, teaching, and training abroad** for the **academic year 2025/2026**, which must be **completed no later than 28th February 2026**.

1. Eligibility Requirements and Application Procedures

To participate, candidates must meet the requirements indicated in Art. 2 of the mobility call issued with Director’s Decree n. 2055 Rep. n. 235/2025 on 24/07/2025.

Applications must be submitted **exclusively online** by 24:00 on **15th January 2025**, through the same link provided in the original call.

2. Selection and Grant Allocation Procedures

This notice operates on a **rolling (“sportello”) basis** and does **not** provide for the formation of a merit ranking.

Applications will be accepted in **chronological order of submission** within the specified timeframe and based on the **available financial resources**. Applications submitted after the previous deadline and before the publication of this notice will, in accordance with the rolling (“sportello”) principle, be evaluated with priority in the first awarding round.

To ensure efficient and timely use of the available EU funds within the final deadline, every 10 days, grants will be awarded to eligible candidates, giving **priority to** applicants who have **not** already been awarded a grant within the same CALL and **to applicants whose mobility begins earlier**, until all available funds are exhausted.

Although this is a rolling procedure, a summary list of the awarded grants will be published at the end of the application period, ensuring full transparency of the process.

3. Early Closure of the Application Window

The application window will be **closed earlier than 15th January 2025** in the event of the **early exhaustion of available funds**.

4. Publication and Transparency

The list of applications **approved for funding** will be published on the **International Relations Office website**: <https://internazionale.unibas.it/site/home/bandi-e-iniziative-pnrrtne.html>, as well as on the **University of Basilicata (Unibas) website**: <https://service.unibas.it/albo/albo.html>, every ten days until the tenth day after the close of the application window.
